

SRA Boat Storage and Fee Policy

Effective through December 31, 2017

Fee Structure:

- (1) **SRA Membership Fee.** All boat owners who wish to store private boats at Sammamish Rowing Association's Hod Fowler Boathouse must become SRA members and pay the annual membership fee of \$300 as well as the appropriate boat storage fee.
- (2) **Boat Storage Fees.**
 - a) **Single:** Annual storage fee: \$1,000 includes one year-long Independent Rowing Card (IRC) + one set oar storage
 - b) **Double:** Annual storage fee: \$2,000 includes two year-long Independent Rowing Cards (IRC) + two sets oar storage
- (3) **Boat Storage Location.** All boats are subject to relocation within the boathouse at any time by the Boathouse Manager. The Boathouse Manager will attempt to notify the owner of an intended move if possible. All boats will be located to provide access to the owner. However, boats that are not used by boat owners but are simply stored may be located to areas with limited access.
- (4) **Private Boat Insurance**

All SRA members who store boats in or outside the Hod Fowler Boathouse are required to obtain and maintain private insurance for the stored boat. SRA does not maintain property insurance for any members' boats or sculls.
- (5) **Boat Storage Agreements.**

All private boat owners must renew annually their intent to store their boat(s). A new signed Boat Storage Agreement (see next page) must be submitted each year. Space in the boathouse is not guaranteed. All fees due for prior periods must be paid in full by the boat-storage renewal date. Boat owners must keep their accounts current to retain their rack space. If a Boat Storage Agreement is not received or fees and dues are not paid by the effective date of the Agreement, the boat will be removed from the boathouse at the owner's risk and expense.
- (6) **Boat Removal Policy.**
 - (a) **Non-payment/Noncompliance with SRA policies.** The boat of any private boat owner who fails to comply with SRA policies, fails to pay membership or storage fees, or fails to submit his or her Boat Storage Agreement will be subject to removal from the boathouse. SRA will provide notice of removal at the boat owner's last known address. If the owner does not remove the boat within 30 days, the boat will be removed from the boathouse at SRA's discretion and returned to the boat owner's last known address if in the greater Eastside area. If no such address is known, the boat will be relocated outside the boathouse. If the boat remains outside the boathouse for 60 days or more or is deemed to be a nuisance/violation of any governmental regulation, it will be deemed abandoned and donated to the club. The club will then use or dispose of the boat at its discretion.

(b). Renewal of Boat Storage: Private boat owners who comply with all Boat Storage Policies as listed above will retain their rack space for the duration of that calendar year. However, SRA reserves the right to not offer renewal at the end of the year if the club requires the use of a private rack. The Executive Director will handle such decisions on a case-by-case basis.
